




GDP growth in annual terms, trln KZT




GDP growth in annual terms, bn USD



The consumer price index in July 2021 compared to the previous month was 100,7%:

- food prices rose by 0,7%;
- non-food products rose by 0,5%;
- paid services increased by 0,8%.

Since the beginning of the year (July 2021 compared to December 2020), prices and tariffs for consumer goods and services increased by 5,3%, including food products – by 7,3%, non-food by 4,5%, paid services by 3,6%












Assets of second tier banks

Banks' deposit portfolio









— UAPF assets to GDP, %










