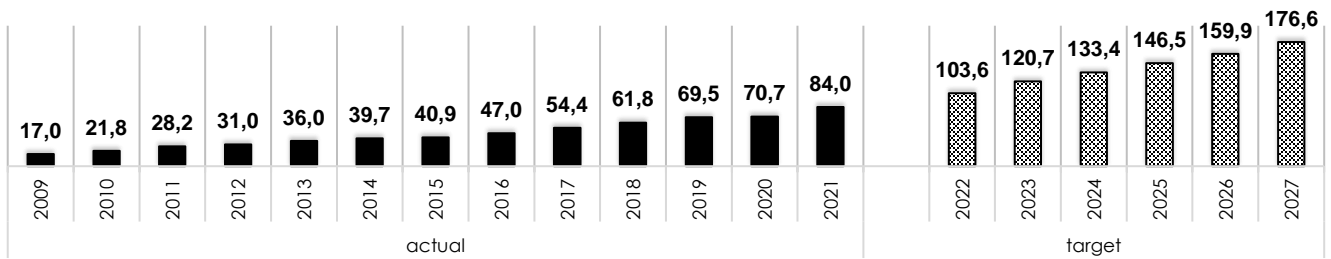

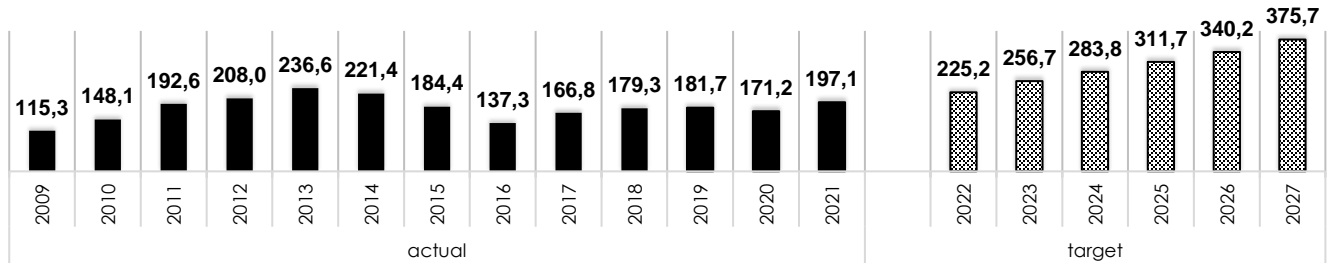

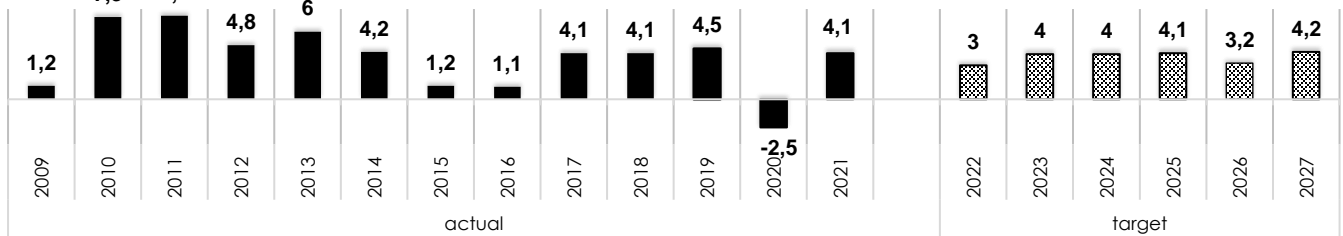
## GD, growth in annual terms, trln KZT



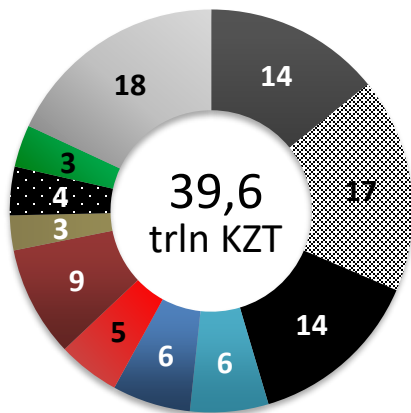
## GDP growth in annual terms, bn USD

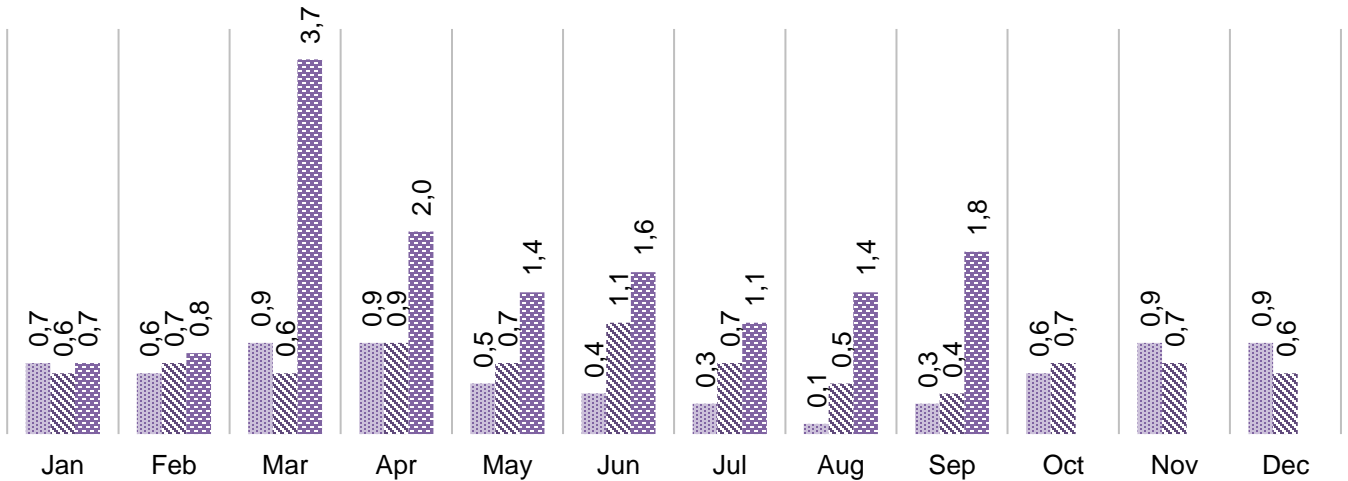

The consumer price index in August 2022 compared to the previous month was 101.8 %:

- food prices rose by 1.2 %;
- non-food products rose by 1.9 %,
- paid services increased by 2.7 %,

Since the beginning of the year (August 2022 compared to December 2021), prices and tariffs for consumer goods and services increased by 15.4%, including food products – by 19.5%, non-food by 14%, paid services by 10.8 %

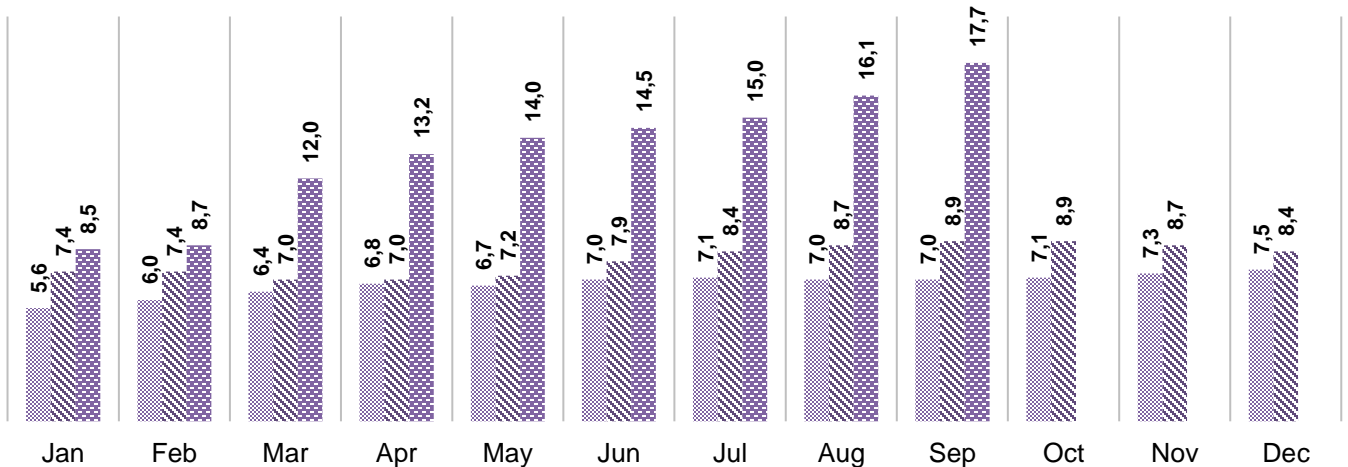

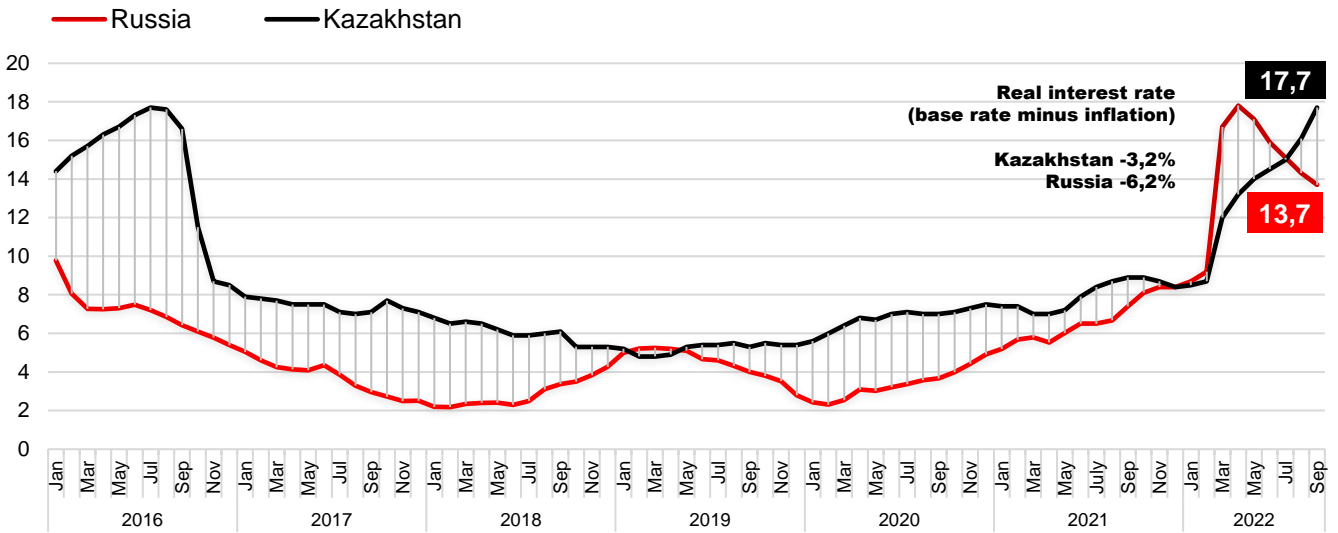

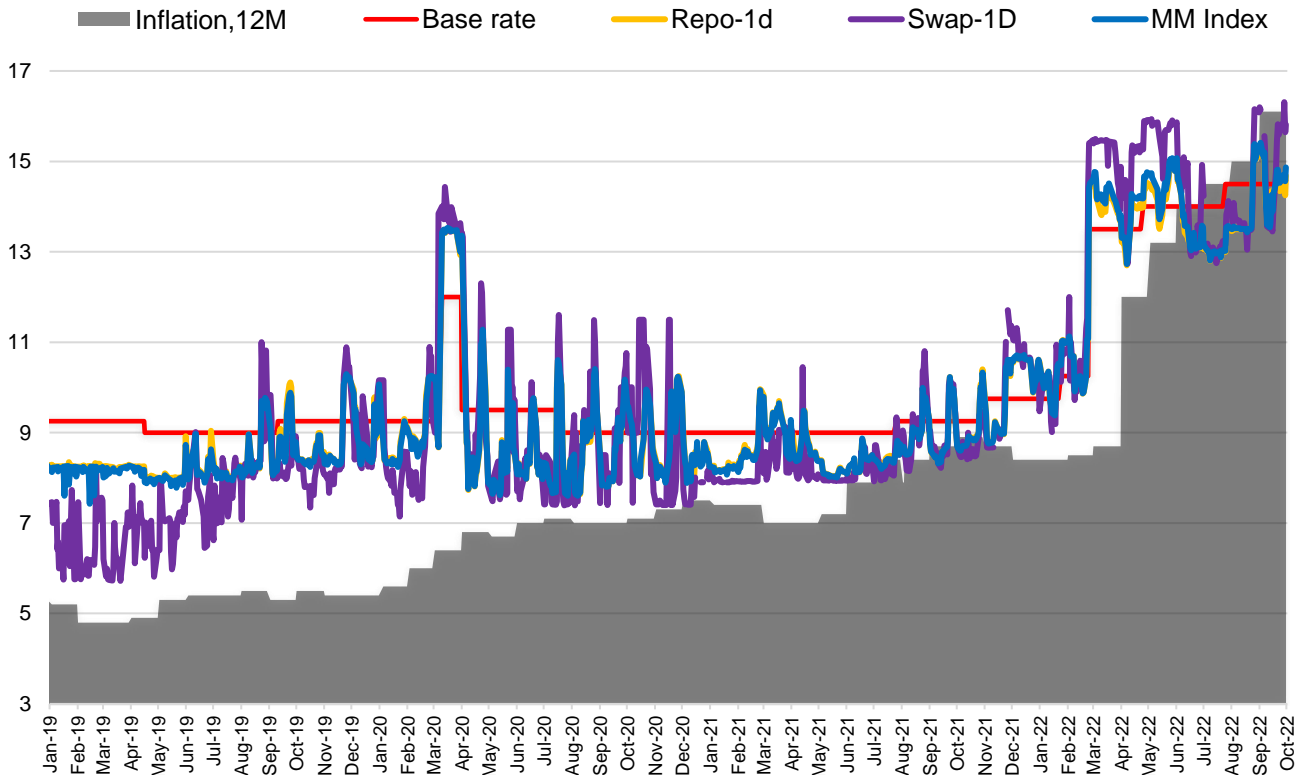

Inflation and interest rates

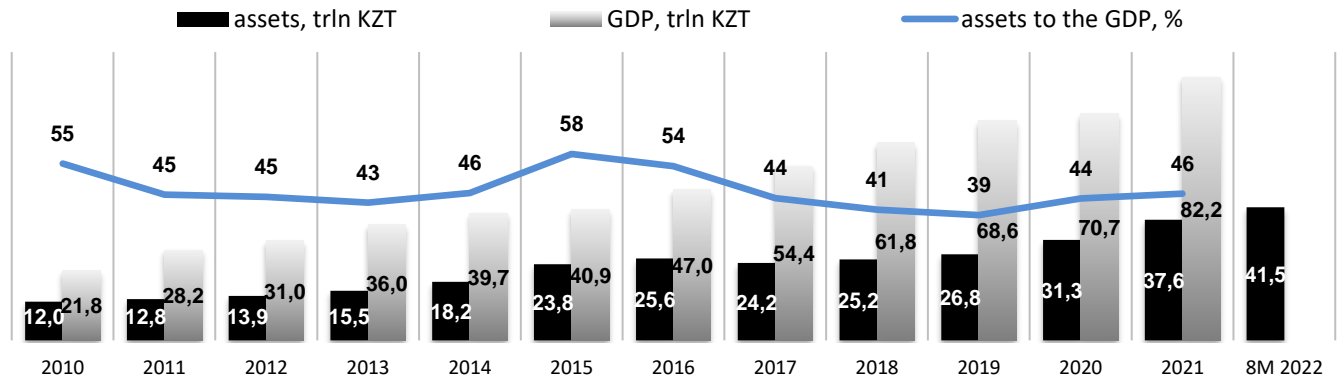

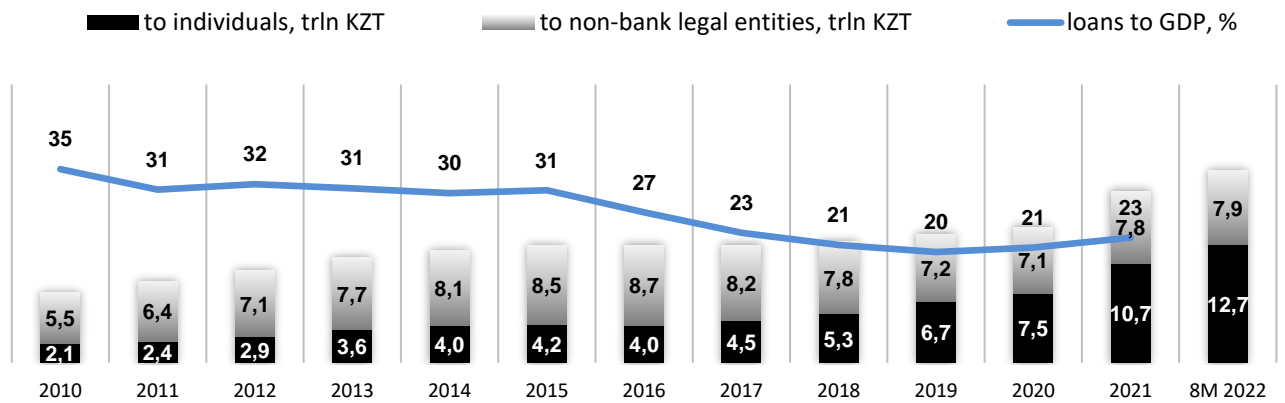

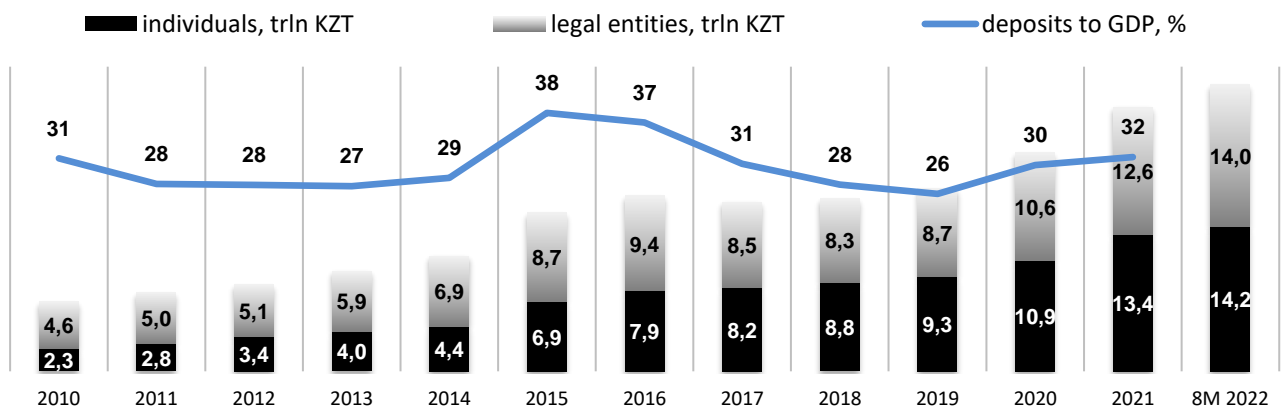
## Assets of second tier banks



## Banks' loan portfolio



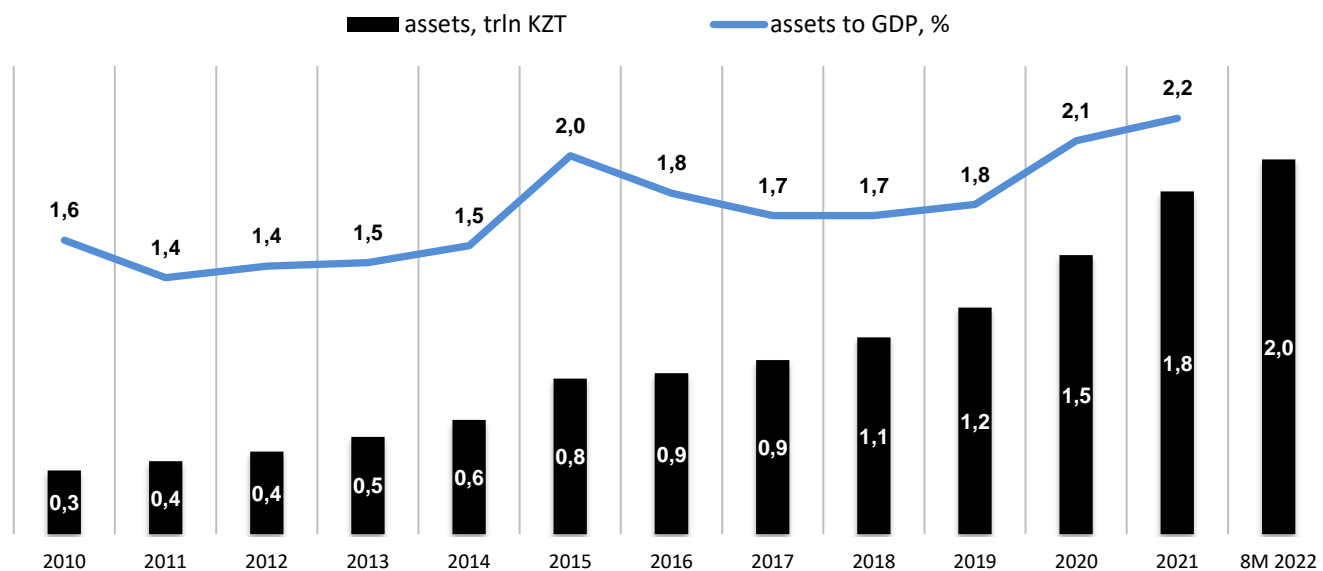
## Banks' deposit portfolio



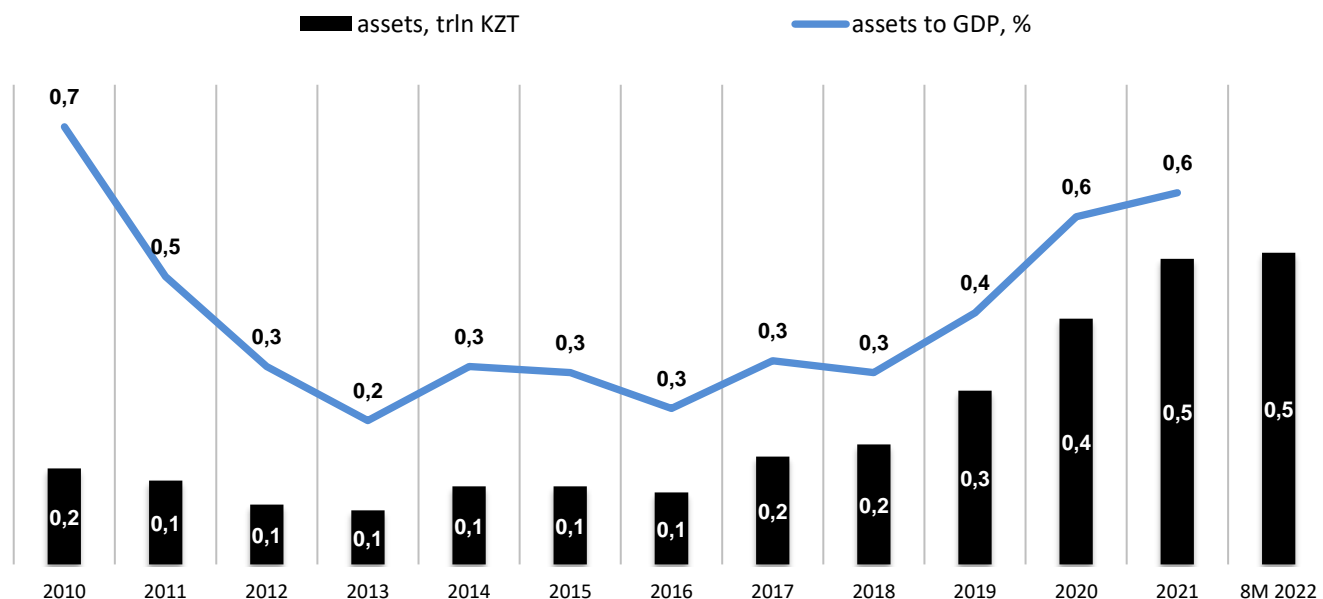

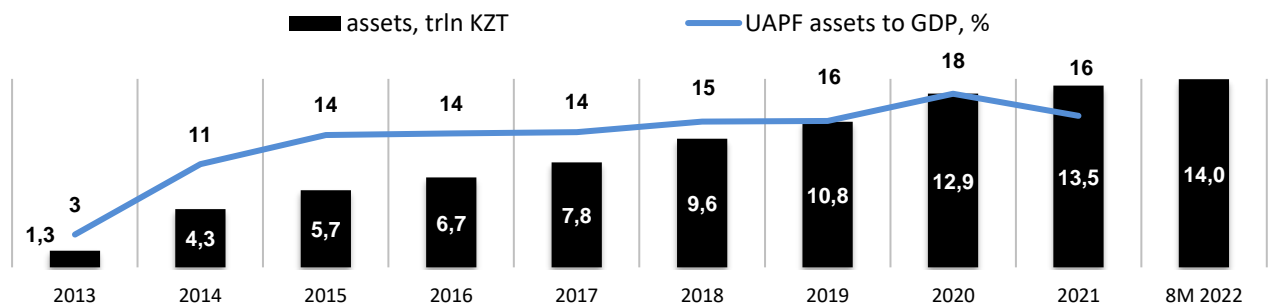

## UAPF assets/GDP, %



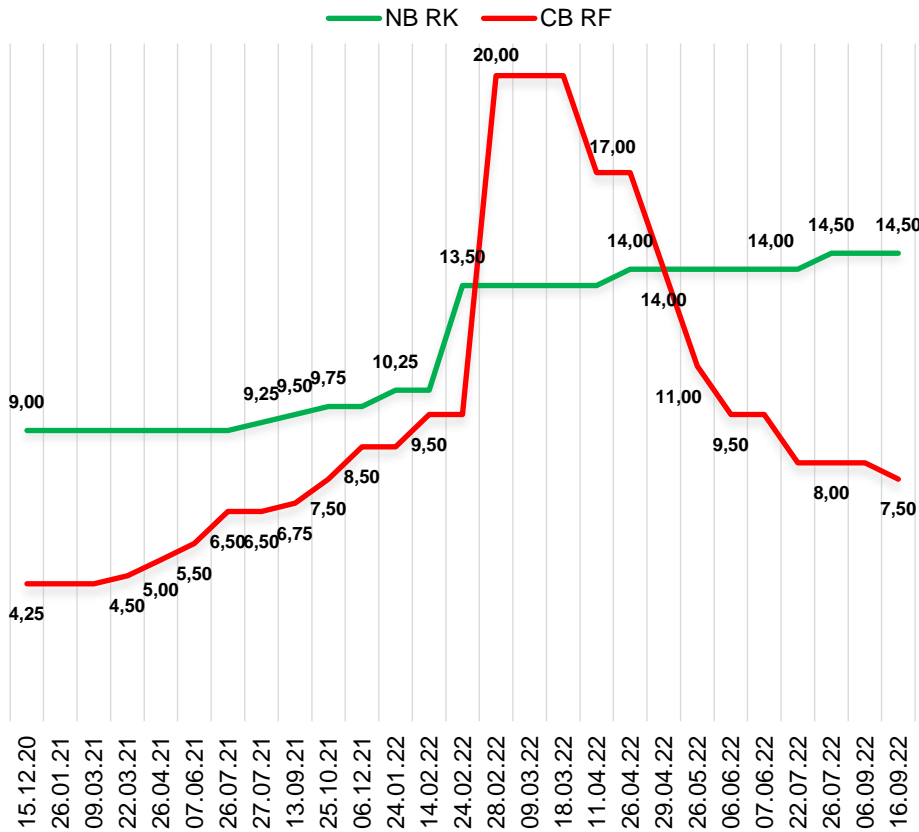

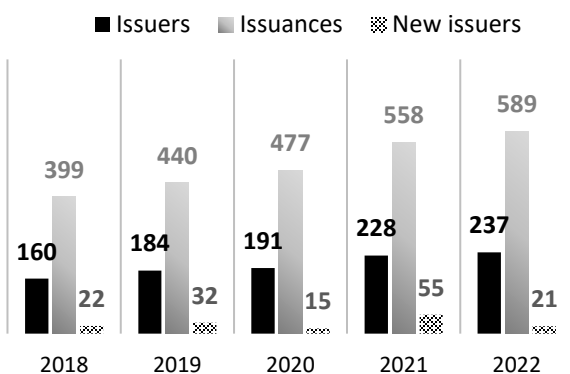

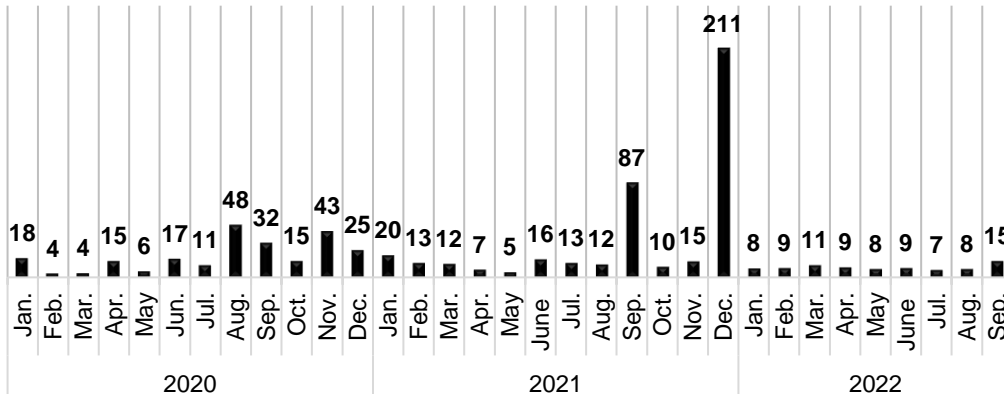

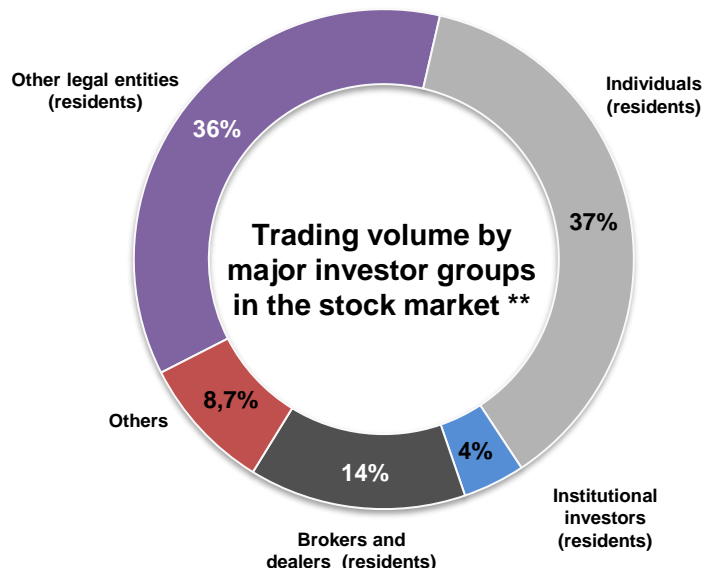
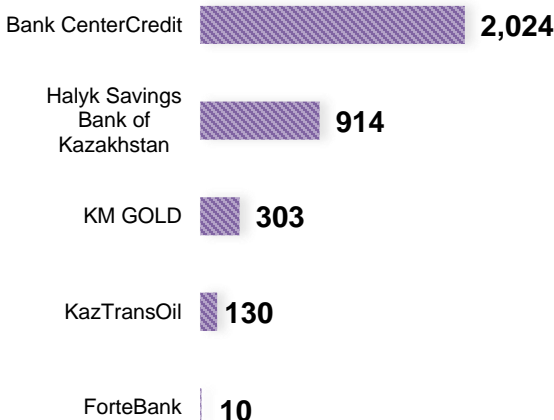
