2. The Chairman of Board of JSC "KEGOC" (Kazhiyev B.T.) shall take all necessary measures related to the implementation of this decision.

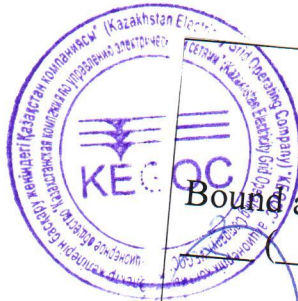
