The National Company “Astana EXPO-2017 JSC was founded on January 15, 2013 for preparing and holding EXPO-2017 the International Specialized Exhibition. The exhibition will be held in Astana from June 10 through September 10, 2017.

100 countries, at least 10 international organizations, 10 leader companies of innovation technologies are expected to participate in this exhibition. In general, over 2 million visitors and about 5 million visits are expected.
