### **Sberbank Online – even closer, even better!**

**January 15, 2018, Almaty** - Large-scale updates are made in Sberbank Online. The limits have been increased for the maximum amount of transactions up to KZT 3,000,000 per day. Also, clients can conduct 2 transactions for the amount up to KZT 5,000 per day without the password confirmation via SMS. In addition, functions to create goals for accumulation and sending loan applications for clients not having Sberbank card are added to the guest and anonymous Sberbank Online. Now, users of Sberbank Online can log in by Face ID on Iphone X and set a profile picture in the context menu.

#### **Limit for the maximum amount of transactions up to KZT 3,000,000 per day**

- At the initial registration a client can make transactions for the amount up to KZT 100,000. If it is necessary to exceed the limit, a client must be verified by contacting the Call Center. The limit will be increased up to KZT 500,000 per day on a permanent basis. This is done for the safety and protection of the client's finances.
- The total limit for external transactions in Sberbank Online is KZT 3,000,000 per day.

#### **Making transactions without SMS in Sberbank Online**

- Sberbank Online user can make two transactions per day for the amount not exceeding KZT 5,000 per each transaction without the password confirmation via SMS;
- The service does not cover payments in the following companies: Olympus, Qiwi, Yandex-money.

#### **Automatic transfers**

Now, Sberbank Online users can make automatic transfers: between own accounts and cards, to the cards of Sberbank's clients and other banks, repay a loan in another bank, transfer money by details to a private person or in favor of an organization. The automatic transfer will allow clients to forget about the regular transactions. Sberbank Online will do it for you.

#### **Loan application in a guest Sberbank Online, not for Sberbank's clients**

If the mobile application user is not a client of Sberbank, it can apply for a loan through Sberbank Online. For this purpose, it is necessary to download the application on your smartphone and fill out the application form. In addition, the user can add a card of another bank and make more than 1,500 payments in Sberbank Online mobile application.
